# Idaho Steelheads Ticket Contract Information

We respectfully request that you carefully review the following information. By submitting your payment for your Steelheads season tickets, you agree to comply with these policies. Thank you for your consideration and your support of the Steelheads.

### Ownership of Seat Locations

The Steelheads own and control all rights to seat locations for the Steelheads home games. Purchasers of "season tickets" receive a license, in the form of a ticket, to use the seat location for the designated regular season home game printed on the ticket. This license is granted on a game-by-game basis, and is subject to all rules, regulations and policies relating to tickets established from time to time by the Steelheads, CenturyLink Arena or the ECHL and may be revoked at any time. The Steelheads reserve the right to relocate your seat location at any time and/or change association or league affiliation. Season ticket holder assumes all risk in attending events, including any personal injury or damage to or loss of property of season ticket holder and guests.

### Compliance with Rules & Regulations

Season ticket holder agrees to comply with rules and regulations adopted by the Steelheads, CenturyLink Arena, and the ECHL, and to ensure that their guests comply with such rules. Season ticket holders and their guests shall comply with all present and future laws, ordinances, orders, rules and regulations of all governmental authorities. Season ticket holder will not engage in or allow their guests to engage in any conduct which interferes with any other person's enjoyment of games or events at the Arena. The Steelheads reserve the right to modify rules and regulations at any time.

### Season Ticket Holder of Record

The season ticket holder of record is the individual or company which is identified as the contracting party on the season ticket agreement. The season ticket holder of record should provide the Steelheads with the contact person for the account, particularly in the case of a business. The Steelheads may exercise discretion in accepting payment(s) from the third party(s) and such acceptance shall not confer any season ticket holder privileges, including without limitation, renewal to the third party or cause the Steelheads to change the name of the season ticket holder on the account.

### Season Ticket Privileges Non-Transferable

Season ticket holders have no right to transfer seat locations designated by their tickets to any person or entity, whether by a request to transfer the account into another name, or by an attempt to transfer the seat locations or the renewal privileges below by sale, gift, by will or trust, property settlement, transfer to creditors, or by any other means. Any attempt to sell or otherwise transfer season ticket privileges to third parties will not be recognized by the Steelheads and may result in cancellation of the season ticket account and all privileges. Any court order directing distributing to a person not listed as the season ticket holder, whether in bankruptcy or otherwise, will result in the Steelheads exercising its right to immediately withdraw the license represented by the tickets, including any season ticket renewal privileges, upon refund by the Steelheads of all amounts paid for games not yet played. Businesses wishing to change the name of the contact person on their accounts may do so only through submitting a written request on their company letterhead. The Steelheads reserve the sole right to approve or deny any such request.

### Ticket Rights of Season Ticket Holders

Season ticket holders may be afforded a first right of ticket purchase for certain special events held at the CenturyLink Arena. Season ticket holders will be assigned the same seat location each

year and upon renewal. Requests for seat relocation are accepted during the renewal period only. The Steelheads reserve the right to relocate your seat location at any time.

### Renewal Procedures

Season ticket renewal notices will be mailed to the contact person for each account. Due to the time necessary to remarket, process relocation requests, print and distribute tickets, accounts that do not meet renewal or payment deadlines will be subject to cancellation. If you have not received a renewal notice by June 1<sup>st</sup>, please contact the Steelheads ticket office for assistance. If you do not contact the Steelheads office by June 30<sup>th</sup>, you will be deemed to have waived your renewal privilege. Once payments for season tickets are received they become non-refundable.

### Playoff Tickets

Season ticket holders are afforded a first right to purchase your same seat location and any additional tickets for the ECHL playoff games prior to them going on sale to the general public. A "Pay As you Play" playoff agreement will be sent out prior to each year's playoffs. By submitting your "Pay As You Play" agreement, you agree to purchase tickets to all possible ECHL playoff games for that season. Upon conclusion of each playoff round, season ticket holders who purchased playoff tickets will have their credit card charged for all Idaho Steelheads home playoff games played at the CenturyLink Arena during that round. The same rules and regulations, terms and conditions apply to preseason and playoff tickets.

### Additional Season Ticket Requests

If you are interested in purchasing additional season tickets, please indicate in the comments field of your renewal form or contact the Steelheads ticket office to be placed on the priority list. Please be as specific as possible regarding acceptable seat locations.

### Distribution of Tickets

Any outstanding balance with the Steelheads must be paid in full before tickets can be distributed prior to the start of the Steelheads regular season. The Steelheads reserve the right to approve or deny any request to distribute season tickets to a person other than the contact person for the account. The Steelheads reserve the right to mail out season tickets or they may require the account holder to pick the season tickets up from the Steelheads office. Steelheads are not responsible for lost, stolen or damaged tickets.

### Agreement is Non-Cancelable

By signing your season ticket agreement, you are signing a contract that is non-cancelable and become of force upon acceptance for the entire term of the agreement.

### Change of Address/Other Notices

It is the ticket holder's responsibility to notify the Steelheads ticket office, in writing and signed by the contracting party for the account, of any changes in address to assure delivery of notices and other dated materials from the Steelheads. Business accounts must submit any change notice on company letterhead with the signature of the contact person or an appropriate company official. Please include the season ticket account number and a daytime phone number for the contact person in all correspondence.

### Payment

Payment in full is due by August 1<sup>st</sup> prior to the start of each season. Once payments for season ticket are received they become non-refundable. Past due accounts are subject to administrative charges (calculated at 1.5% of any outstanding balance).
